## A Resolution Governing Fee Schedules for Vital Statistics

Resolution 2025: \_\_\_\_

WHEREAS, Union County has been designated a primary registration district for vital records by Ohio Revised Code Section 3705.04, and;

WHEREAS, the local registrar of vital statistics shall supply blank forms of certificates and instructions to such persons as require them, and shall require each birth, fetal death, or death certificate, when presented for filing, to be made out in accordance with sections 3705.01 to 3705.29 of the Ohio Revised Code, the rules adopted by the director of health, and the registration instructions of the director, and;

WHEREAS, Ohio Revised Code sections 3705.24 (B)1 Fees - annual certification by director of health to county treasurers; 3109.14, Fees for vital statistics records, and; 3705.242 (A)1 Fee for copy of birth or death records - divorce decree filing fee establish the state minimums to be collected for vital statistic fees, and;

WHEREAS, the Union County Board of Health acting under the authority vested in it by Ohio Revised Code Section 3709.21 of the Ohio Revised Code may adopt regulations necessary for the public health and safety and the prevention and restriction of disease; and,

WHEREAS, the Union County Board of Health, acting under the authority vested in it by Ohio Revised Code Section 3709.09 may establish a uniform system of fees to pay the costs of any services provided by the board; and.

WHEREAS, the Board of Health seeks to recoup some or all of the program expenses associated with these activities,

NOW THEREFORE, be it resolved that the following fees shall be charged beginning December 1, 2025 for the listed vital statistics and related activities:
